WHEREAS, on or about March 26, 2013, this Court issued Pretrial Order No. 61 granting 1 in part and denying in part the motions to dismiss, including with respect to claims against the 2 Officer Defendants, as further reflected in Pretrial Order No. 66 docketed on May 9, 2013; 3 WHEREAS, on or about June 7, 2013, each of the Officer Defendants answered the 4 Amended Complaint; 5 WHEREAS, the parties have now resolved the claims regarding the Officer Defendants, 6 pursuant to the October 18, 2013 Settlement Agreement and Mutual Release. No other party or 7 other person or entity has filed a pleading or action against the Officer Defendants relating to the claims brought by plaintiff, and defendants have not filed or raised a counterclaim in this action. Additionally, on April 24, 2014, this Court entered an order granting the Officer Defendants' 10 Unopposed Motion for Entry of Bar and Judgment Reduction Order. 11 WHEREAS, this stipulation does not include defendant Ernst & Young LLP, the only 12 defendant that will remain in the action; 13 NOW, THEREFORE, pursuant to Federal Rule of Civil Procedure 41(a)(1), the parties 14 hereby stipulate to dismiss the Officer Defendants from the above titled action with prejudice.
