My name is Shannon Thomas. I am a science teacher in Helena, Montana. This email is written as public comment in support of the appointment of James Jeremiah Shea for the position of Supreme Court justice.

I have had the privilege of knowing Jim Shea for over twenty-five years, both as a friend, and as a stellar lawyer and judge. Dear Commission Members:

By way of introduction, I am a senior partner in the largest institutional, corporate, and insurance defense firm in a 5-state region. Over the past 25 plus years, I have appeared in most, if not all, state and federal courts in the State of Montana at one time or another. As Montanans, we are very fortunate to possess the jurists we have presiding over our courts. However, I can unequivocally state that Judge Shea outshines all others. The purpose of this letter is therefore to urge you to include Judge Shea among the candidates to be forwarded to Governor Bullock.

Turning to the basis for my endorsement, an appropriate starting point is the Code of Judicial Conduct. Rule 1.2 provides that, "A judge shall act at all times in a manner that promotes public confidence in the independence, integrity, and impartiality of the judiciary and it shall avoid impropriety and the appearance of impropriety." During the course of Judge Shea's tenure, I have tried several cases to conclusion as well as argued several dispositive motions. I won some and I lost some. However, regardless of whether I won or lost, there was a reasonable basis for the court's decision. More importantly, the decision was fair and the parties left the courtroom knowing that the decision was the result of an impartial application of the law to the facts and not the result of the judge's personal bias or agenda.

A judge should also be temperate, attentive, diligent and hardworking. Judge Shea possesses each of those traits. His judicial demeanor is impeccable. He is also a hardworking, thoughtful, intelligent jurist who delivers well reasoned decisions which attempt to follow the ever changing state of the law in an arena of legal and medical complexity. His intellect,

diligence, and analytical skills have consistently resulted in the Supreme Court affirming his decisions on appeal.

Finally, Judge Shea demands courteousness, professionalism, and civility in the practice before his court. He has no tolerance for unprofessional conduct. He has the strength to withstand partisan demands and public clamor. During his tenure, there has been an absolute prohibition upon ex parte communication. In short, Judge Shea is a textbook example of the traits and characteristics that the Code of Judicial Conduct requires of a sitting judge.

In light of the above, I am confident that Judge Shea would make an outstanding Montana Supreme Court Justice. I therefore urge you to submit his name to Governor Bullock for appointment.



Dear Members of the Judicial Nomination Commission,

I am writing to you to recommend Judge Shea for the Supreme Court vacancy. I have been in practice in Montana since 1982 and for about the last 19 years I have practiced exclusively before the Montana Workers' Compensation Court representing workers compensation insurers. I was the second law clerk in the Workers' Compensation Court (with the Hon. Timothy Reardon presiding). I was also Judge Reardon's Hearing Examiner and presided over hearings in the Court. I have tried cases before three of the four judges to preside in that Court.

I have also represented clients in many Montana Supreme Court appeals, including oral arguments. My next oral argument is on May 6, 2014, and is an appeal of a decision of Judge Shea involving a constitutional challenge to a statue that the Supreme Court must be given the opportunity to review. Based on my experience in the Supreme Court I am convinced that Judge Shea's temperament and personality will be a good fit for the Court and those who appear before it. He is very personable and does not fluster. He treats the attorneys and their clients in a way that sets a tone of civility and respect that helps make the workers compensation bar very collegial. I have had many conversations with Judge Shea about such topics as movies, hunting and other shared interests. He has a rich and varied life outside the law which I believe is very important to have an informed perspective and balanced judgment.



Dear Commissioners:

I am pleased to write in support of the appointment of Judge James J. Shea to the Montana Supreme Court.

I have come to know and greatly respect Judge Shea in my practice with Carey Law Firm, P.C. Much of our firm's practice involves representing workers' compensation claimants, and I entered the practice shortly after Judge Shea was appointed to the Montana Workers' Compensation Court. I can personally attest that learning the intricacies of our workers' compensation statutes and corresponding case law is no easy task, and our firm was curious to see how Judge Shea would handle that task with little prior experience with the workers' compensation laws. I had a seasoned mentor to bring me along in this regard, and yet it seems I learn something new every day. Judge Shea had to bring himself up to speed on this unique area of the law essentially without a net.

While *Thompson* was ultimately reversed on procedural grounds, Judge Shea's acumen in applying the law to the facts of a particular case is evidenced by his 87.8% affirmation rate with the Montana Supreme Court on appeal. This speaks volumes to his astuteness as a judge. Having tried several cases before him, I can also attest that Judge Shea possesses all of the qualities Montanans and attorneys from both sides of the aisle expect in a Montana Supreme Court Justice. He is intelligent, considerate, gracious, objective, at times humorous, analytic in his thoughts, and strives at all times to follow the law. I met Judge Shea when we were both members of the University of Montana Law School class of 1991. I have known him for more than 20 years. I write to you today to explain why I think he is the best candidate for the seat recently vacated by Justice Morris.

Following his clerkship with U.S. District Judge Paul G. Hatfield, Jim spent the next fourteen years advocating for ordinary people, first as a public defender in Portland, Oregon, then as an associate with the Portland firm Bricker, Zackovics and Querin, and finally as a partner in the Missoula firm Paoli & Shea. His public defender work included both misdemeanor and felony cases. His civil litigation work required him to represent clients in a wide variety of forums, including jury and non-jury trials in every state in the Pacific Northwest. This combination of significant practical experience in both criminal and civil law, in several states, is unusual and distinctive in the Montana bar.

Judge Shea also has significant practical experience actually working as a judge. Ladies and Gentlemen of the Commission:

As a citizen of Montana, I wish to make comments on several of the applicants for the Supreme Court vacancy left by Justice Brian Morris' appointment to the federal bench. Now, I'm not an attorney, and, like most humble Montana peasants, hope to end my days never seeing the front side of the courtroom railing.

First off, it is very clear to me that very few Montanans have chosen to participate in the process. While the process is commendably very public, there seems little to no interest from the public. There are few if any comments from average Montanans, mostly letters of endorsement from friends, past clients and professional associates of the applicants. That's a shame, a clear indication of how Supreme Court affairs are an "inside game" for those with inside knowledge only. It also may be that quite a number of Montanans DO know some of the applicants, but feel they are wasting their time participating.

Why would Montanans feel so? It is a sad fact that the popular electoral selection of statewide Montana Supreme Court justices is dysfunctional.

The financing of various judicial races almost always breaks down along factional lines, with the trial lawyers' plaintiff bar paying the most into the betting pool, basically because they have the most to win or lose by the election of a sympathetic judge.

Regular Montanans only rarely bet on these elections, because they often have no direct stake, no direct interest. The result of underfunded, under-noticed campaigns is that voters know almost nothing about the candidates before them, and the usually narrow election margins hint at nearly-random patterns of voting.

The only exceptions are when the Supreme Court candidate held partisan political office at some point and has name recognition – Chief Justice McGrath being a classic case in point.

I am not writing to endorse anyone, but rather to express my opposition to several applicants who seem to have an activist approach which they'll likely bring to the Supreme Court if appointed.

Elizabeth (Beth) Ann Brennan: I oppose Ms. Brennan. She has been a member of the Board of Directors of the Clark Fork Coalition, an environmental group.

While in law school, she collaborated with radical, peripatetic environmentalist lawyer Jack Tuholske on a law review article covering the National Forest Management Act. Mr. Tuholske, of course, moonlights as a law school professor who teaches young earth muffins how to sue the Feds and stop stuff.

But most objectionable is Ms. Brennan's membership in Public Justice, formerly Trial Lawyers for Public Justice. TPLJ was founded by that great centrist Ralph Nader in the early 1980's as a means of bringing forth "high-impact, cutting edge litigation" and to "build a record of precedent-setting litigation for the public good" including lawsuits attempting to hold firearms makers liable for end-user abuse.

Another TPLJ alumnus of note from Montana happens to be Senior Judge Donald W. Molloy. He was pursuing a very "innovative" work-comp case for TPLJ when appointed to the federal bench – where, as the Lincoln County commission put it in 2011: "Molloy's career […] has been a social and economic disaster for Montana rural communities in general, and Lincoln County in particular." Picking another Naderite for any court in Montana would be bad form – leave that up to Montanans in the next Supreme Court election, which Ms. Brennan has shown interest in for some time.

Amy Poehling Eddy: While Ms. Eddy certainly seems to collect the kudos from her fellow trial lawyers, and enjoys a seat on the Board of Governors of ATLA (now renamed the American Association of Justice), the fact remains she was attorney of record for the Barhaugh "public trust" case. I would not say that is something to brag about.

In short, Ms. Eddy fronted a forum-shopping expedition for a silly "childrens' campaign" (actually run by Mom), and not content to wait for a district court case and appeal, went straight to the top with a bid for an immediate ruling by the Montana Supreme Court.

The end game was to completely bypass the Montana legislative process and force the state to implement programs to prevent global warming, regardless of economic impacts, regardless of the scientific merit of climate change and its root causes.

This was an incredible overreach, the worst sort of litigational activism, and was shot down, I believe unanimously, by the Montana Supreme Court. That she would have the temerity to seek appointment after such a slap-down only underscores her activist zeal. A bad fit, period.

Ed Sheehy: I voted against Mr. Sheehy last time around and wish he would get the message. I understand his father was a Supreme Court justice and Ed wants to follow. I can even understand that someone has to defend whacko killers, who do deserve a fair trial under strictest evidentiary standards.

But Mr. Sheehy is clearly a man who believes the death penalty is inherently unjust, that the worst, most irredeemable animals do not deserve to be "put down" for the most heinous of crimes, even when their guilt is absolutely not in doubt.

Counselor Sheehy's defense of the Kalispell Christmas killer, Tyler Miller, scoring Miller two life raps instead of the death penalty, as well as his years trying to keep Canadian guest killer Ronald Allen Smith alive, for possible repatriation to Canada after slaughtering Harvey Mad Man and Thomas Running Rabbit in cold blood for their grandma's car, force me to conclude that Mr. Sheehy has a warped sense of justice. He is therefore a bad fit for the Supreme Court, or any judgeship, anywhere.

As for the rest of the slate, I did note that almost without exception, these are Democratic political contributors who also have donated money to Supreme Court races – more of that inside baseball by the legal elite in this state, and not a surprise considering our Governor making the final decision here is, yep, a Democrat.

If I had to recommend any applicant, I would say that James Shea, the work-comp judge, and David Ortley, judge from Kalispell, both deserve to be advanced to Governor Bullock for consideration. Their main qualification is that both have been on the bench for a while, and basically, not blown the walls off the courthouse with any crazy stuff during their tenures.

Thank you for your consideration. Please choose wisely.
